### 2. Minutes from the last meeting

### 3. Approval of agenda

### 4. Judging issues/ clarifications

Sidestep exercises.

In the sidestep exercises, if the dog moves backwards and then forwards again.	-1 lack of teamwork for askew position, if applies -3 lack of teamwork
If the dog moves the front and the behind sideways during the exercise.	-1 lack of teamwork for askew position, if applies
If the dog does not move its behind, but follows the handler nose first.	-10 lack of teamwork
The sidestep is not in a straight line	- 3 handler's mistake if deviation is more than half and less than the length of the handler's foot  - 10 handler's mistake if deviation is more than the length of the handler's foot

We discussed examples of specific judging situations where the guidelines are interpreted differently by judges. It was pointed out, that at the championships the chief judge has the final word in such matters.

The Facebook group Nordic Class Rally Obedience FAQ was discussed. It was agreed that official answers will be given by the NKU Rally Obedience Committee, the answer will start with: Answer from NKU Rally Obedience Committee. The members of the Committee are group administrators in the group. Solveig will make the necessary updates.

### **5. Coming championships**

The plan is to host the Nordic championship at Nova Spectrum during the Oslo Dog Show probably in November 2023. Hopefully this will be clarified Monday 8<sup>th</sup> August 2022. Plan B (Stovner Hundeklubb) will be discussed if needed.
