Agreement	<p>The following agreement is valid from _____ up until _____ (no more than 1 year).</p> <p>With this agreement, the owner of the bitch deeds the breeding right for the above bitch to the borrower. The deed relates to the right of the borrower to one litter of puppies with at least one living puppy achieving the age of 5 weeks.</p> <p>The deed includes the right of the borrower to use the bitch for mating no longer than 2 weeks, for whelping no longer than 3 weeks before and up to 10 weeks after the whelping.</p> <p>The borrower shall manage the mating, whelping and rearing.
