This agreement cannot be used as proof of mating. Bitch must be at least **18 months** old at the time of mating.

The above-mentioned parties, who own the breeding rights to the dog and the bitch, have reached an agreement according to one of the following alternatives:

- ☐ **Alternative 1.** The mating fee (so-called stud fee) is partly SEK which shall be paid against receipt in conjunction with the mating and partly SEK per puppy achieving the age of weeks. One condition for the owner of the bitch to have to pay a jumping fee at the time of mating is that the male mates the bitch, regardless of whether hanging takes place or not. The latter fee shall be paid no later than when the puppies achieve the above-stated age against receipt and signed application for registration. In the event the bitch fails to conceive, the owner of the bitch shall not be entitled to repayment of the stud fee.

In the event the bitch fails to conceive, the owner of the dog shall offer the right to a re-mating free of charge.

If the dog is sold, dies or for some other reason cannot participate in remating, the owner of the bitch has the right to immediate repayment of the stud fee.

If a puppy dies after reaching the age specified above, but before the age of 8 weeks, the owner of the bitch has the right to repayment of the fee paid for the puppy, provided that the parties have ticked Yes in the box above.

- ☐ **Alternative 2.** The mating fee (full fee) is SEK which shall be paid against receipt in conjunction (with or without hanging) with the mating whereby the owner of the bitch shall receive a signed application for registration. In the event the bitch fails to conceive, the owner of the bitch shall be entitled to a re-mating free of charge within months. The dog owner must promptly sign the registration application at request of the owner of the bitch.
- If the dog is sold, dies or for some other reason cannot participate in remating, the owner of the bitch has the right to immediate repayment of the stud fee. ☐ Ja ☐ Nej
- ☐ **Alternative 3.** The mating fee is one mating puppy if the bitch gives birth to puppies or more. First choice of puppy is added ☐ Dog owner ☐ Bitch owner. The dog owner must, after choosing of puppy has been done and documented, promptly sign the registration application at request of the owner of the bitch.. If fewer than puppies are born, the mating fee is SEK per puppy that reaches weeks of age. The latter fee shall be paid no later than when the puppies achieve the above-stated age against receipt and signed application for registration.
- ☐ **Alternative 4.** Alternative 4 and any further agreements, see the appendix.

If the bitch/male is to remain with the owner of the dog/bitch in connection with the mating, SKK recommends that the parties establishes SKK's boarding agreement.

The intention of this agreement is for the puppies to be registered in SKK, therefore the parties undertake to respectively breeding animals meet SKK's requirements for registration of litters of puppies, and that neither party is subject to disciplinary action that affects the possibility of registering the litter of puppies. The parties also certify that they have provided truthful and complete information about their breeding animals.

SIGNATURES

With this agreement, the parties undertake to comply with the regulatory framework of the Swedish Kennel Club.

Two identical copies of this agreement have been drawn up, of which each party has received one. If there is an appendix, this has also been drawn up in two identical copies, of which each party has received one.
